

OFFICIAL RULES

DIABLO III REAPER OF SOULS 2ND ANNIVERSARY SWEEPSTAKES

1. Eligibility. BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION (REFERRED TO HEREIN AS "SPONSOR") IS THE SPONSOR OF THIS SWEEPSTAKES. THIS SWEEPSTAKES IS OPEN ONLY TO RESIDENTS THE UNITED STATES, ARGENTINA, AUSTRIA, BELARUS, BELGIUM, BELIZE, BOLIVIA, BULGARIA, CHILE, CANADA, CROATIA, DENMARK, ECUADOR, EL SALVADOR, ESTONIA, FRANCE, FINLAND, GERMANY, GREECE, GUATEMALA, HONDURAS, HONG KONG, HUNGARY, ICELAND, IRELAND, ISRAEL, ITALY, JAMAICA, JAPAN, LATVIA, LITHUANIA, LUXEMBOURG, MACAU, MEXICO, NICARAUGA, NORWAY, PERU, PORTUGAL, PUERTO RICO, ROMANIA, RUSSIA, SERBIA, SLOVAKIA, SOUTH AFRICA, SOUTH KOREA, SPAIN, SWEDEN, SWITZERLAND, TAIWAN, THAILAND, THE CZECH REPUBLIC, THE NETHERLANDS, THE PEOPLE'S REPUBLIC OF CHINA, THE UKRAINE, THE UNITED KINGDOM, TURKEY AND VENEZUELA WHICH ARE: (i) OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST; AND (ii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES; OR THE PROVINCE OF QUEBEC, CANADA; AND (II) WHO ARE THIRTEEN (13) YEARS OF AGE OR OLDER AS OF MARCH 15, 2016; AND (C) WHO ARE NOT RESIDENTS OF THE STATES OF ARIZONA, NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES; OR THE PROVINCE OF QUEBEC, CANADA ("ENTRANTS"). If you are between the age of eighteen (18) years of age and the legal age of majority in your jurisdiction of residence, or your state of residence (a "Minor"), one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these rules with your entry, and that such agreement constitutes acceptance of these rules on behalf of you and themselves. If you reside in the States of Arizona, North Dakota, Vermont, Connecticut or Maryland in the United States, or the Province of Quebec in Canada, you are not eligible to participate in this Sweepstakes. To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. transmissions or entries; (b) telephone, electronic, hardware, software, network, Internet, or other computer- or communications related malfunctions or failures; (c) any Sweepstakes disruptions, injuries, losses or damages caused by events beyond the control of Sponsor; or (d) any printing or typographical errors in any materials associated with the Sweepstakes. Sponsor is not responsible for any incorrect or inaccurate information, whether caused by any other users, by any other technical or human error which may occur in the processing of registrations or entries into the Sweepstakes, or otherwise in connection with the Sweepstakes, including without limitation any technical limitation that results in the disqualification or loss of ranking status of any Entrant into the Sweepstakes.

3. Sweepstakes Period. The Sweepstakes shall commence on 12:01 PM PST March 18th, 2016, and shall continue in duration until 11:59 PM PST April 4, 2016 (the "Deadline"). All entries must be received by the Deadline to be eligible to win a prize.

4. How to Enter

Thereafter, qualified entrants can obtain additional entries to the Contest by participating on the aforementioned URLs through any combination of the following methods. An Entrant can combine their original entry with additional entries as follows to obtain up to a maximum of 3 total entries:

4. Prizes. Within ninety (90) days after the Deadline, Sponsor shall randomly select Entrant's to receive the following prizes:

6. Collection of Information. The Entry Materials include a survey that requires you to enter your name, e-mail address, and state of residence.
