

Official Rules

Heroes of the Storm® “Loot Chest Giveaway Contest”

1. Eligibility. BLIZZARD ENTERTAINMENT, INC., A DELAWARE CORPORATION (referred to herein as "SPONSOR") IS THE SPONSOR OF THIS CONTEST. THIS CONTEST IS OPEN ONLY TO RESIDENTS OF THE UNITED STATES, CANADA, BELGIUM, BELARUS, BULGARIA, CROATIA, CZECH REPUBLIC, ESTONIA, HUNGARY, ITALY, NORWAY, SERBIA, SWITZERLAND, THE UNITED KINGDOM, HONG KONG, SOUTH KOREA, MACAU, TAIWAN, LUXEMBURG, LATVIA, LITHUANIA, GERMANY, FRANCE, AUSTRIA, SWEDEN, FINLAND, SPAIN, POLAND, PORTUGAL, ROMANIA, RUSSIAN FEDERATION, SLOVAKIA, SLOVENIA, UKRAINE, IRELAND, SOUTH AFRICA, TURKEY, AND THAILAND WHICH ARE: (i) OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST; AND (ii) WHO ARE NOT RESIDENTS OF THE STATES OF NORTH DAKOTA, VERMONT, CONNECTICUT, OR MARYLAND IN THE UNITED STATES, OR THE PROVINCE OF QUEBEC, CANADA ("ENTRANTS"). **If you are under the legal age of majority in your country of residence (a "Minor"), one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these Contest rules with your entry, and that such agreement constitutes acceptance of these Contest rules on behalf of you and themselves.** If you reside in the States of North Dakota, Vermont, Connecticut or Maryland in the United States, or the Province of Quebec in Canada, you are not eligible to participate in this Contest. 3. Contest Period. The Contest shall commence on 10:00 AM PST May 30, 2017 (the "Start Date"), and shall continue in duration until 11:59 PM PST June 30, 2017 (the "Deadline"). All entries must be received by the Deadline to be eligible to win a prize.

6. Prizes.

A. Grand Prize Winners. Five (5) Heroes of the Storm Hero and Skin code bundles, with an approximate retail value of \$50.00. one (1) Heroes of the Storm Loot Chest codes worth two loot chests, with an approximate retail value of \$2.00. The approximate retail value of this prize package is \$304.96 USD.

ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZES ARE THE SOLE RESPONSIBILITY OF THE WINNER. All prizes will be awarded. Prize Winners may be required to execute an affidavit of eligibility before they can receive their Prize. 8. Original Work of Authorship. You hereby warrant and represent that (a) you own all rights to all entry materials submitted by you (“Entry Material”); and (b) all such Entry Materials are original works of authorship on your part and have not been copied, in whole or in part, from any other work and do not violate, misappropriate or infringe any copyright, trademark or other proprietary right of any other person or entity.

9. Collection of Information. The Entry Materials include a survey that requires you to enter your name, e-mail address, and state of residence. By entering the Contest, you consent to Sponsor's use of this information to inform you of open positions with Blizzard, and to associate your name with your submission in promotional materials for the Contest in the event that you are chosen to be a winner. As stated above, the contest is not open to anyone under the age of majority in your country of citizenship. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials. In the event that you are a citizen of France and/or any of the other countries whose citizens are eligible for this Contest, and pursuant to French law pertaining to data collection and processing, you are informed that the data collector is Blizzard Entertainment, Inc., and the data collected will be transferred to the United States of America. Entrants who violate these Official Rules, tamper with the operation of the Contest or engage in any conduct that is detrimental or unfair to Sponsor, the Contest or any other entrant (in each case as determined in Sponsor's sole discretion) are subject to disqualification from entry into the Contest. Sponsor reserves the right to lock out persons whose eligibility is in question or who have been disqualified or are otherwise ineligible to enter the Contest.
