

Call of Duty League Custom Kicks Sweepstakes

Official Rules

No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning. Odds of winning depend upon the number of eligible entries received. Void in Puerto Rico and other U.S. territories and possessions and where prohibited.

Eligibility: The Call of Duty League Custom Kicks Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of the 50 United States and District of Columbia (excluding Puerto Rico and other U.S. territories and possessions), who are 18 years of age or older (except residents of Alabama and Nebraska, who must be 19 years of age or older and residents of Mississippi, who must be 21 years of age or older) as of date of entry.
