



**“WIN A CLEANER FOR A YEAR” PROMOTION
TERMS AND CONDITIONS**

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Sukin Australia Pty Ltd (ABN 81 602 062 199) of 58 Logis Boulevard, Dandenong South, VIC 3175. Telephone: 1300 858 898.
3. Entry is only open to Australian residents aged 18 years or over. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Promotion commences on 15/05/2017 and ends at 4:00pm AEST on 15/06/2017 (“Promotional Period”).
5. 6. Limit of one (1) entry per person via the completed online entry form, however individuals may receive one (1) additional entry (giving them a total of two (2) entries into the draw) by opting in to receive marketing material from the Promoter at the time of submitting the online entry form.
7. Incomplete or indecipherable entries will be deemed invalid.
8. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

10. The Promoter’s decision is final and no correspondence will be entered into.
11. The first valid entry drawn will win a house cleaner for a year, from the cleaning agency of their choice, valued at \$2,500.

12. The winner must nominate their preferred cleaning agency to the Promoter, to deliver residential cleaning services only at the winner's home. The cleaning agency nominated must be a registered Australian business with an ABN and, if requested by the Promoter, must be able to provide satisfactory client references. The exact services to be completed and the time and dates of services must be agreed to between the winner and the cleaning agency. The Promoter reserves the right to reject the nominated cleaning agency for any reason, acting reasonably, including (but not limited to), if they are not satisfied that the nominated cleaning agency offers appropriate residential cleaning services. In the event the winner is not satisfied with the services provided by the cleaning agency, the Promoter is not liable to the winner in any way, and the winner must discuss any concerns directly with the cleaning agency.
