

Contest Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Campaign is open only to those who sign up at https://pickleballcentral.wishpond.com/head_revolt_evo_pickleball_shoes/ and who are 18 as of the date of entry. The Campaign is only open to legal residents of the USA, and is void where prohibited by law. Employees of Olla LLC dba PickleballCentral, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

4. **Campaign Period:** Entries will be accepted online starting March 18, 2020 and ending on April 8, 2020. All online entries must be received by April 8, 2020 at 11:59PM PST.

5. **How to Enter:** The Campaign must be entered by submitting an entry using the online form provided at https://pickleballcentral.wishpond.com/head_revolt_evo_pickleball_shoes/. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Olla LLC dba PickleballCentral. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
