

Contest Rules:

A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up at the <http://win.henrys.com/fuji-x-e3-giveaway/> and who are 18 as of the date of entry. The Campaign is only open to legal residents of Canada excluding Quebec, and is void where prohibited by law. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Henry's. Optional verbiage to include: You may enter only once.
