### Terms & Conditions

1. Information on how to enter and the prizes form part of these Terms & Conditions. Entry into this Promotion is deemed acceptance of these Terms & Conditions.
2. The Promotion commences at 12.01pm (Sydney time) on 05/02/2018 and closes at 11.59pm (Sydney time) on 28/02/2018 (“**Promotion Period**”).
3. The Promotion is open to individuals who:
  - i. are residents of Australia;
  - ii. are aged 18 years of age and older;
  - iii. are not employees of the Promoter, or any of its related corporations or any of the agencies associated with the Promotion (including suppliers of the Prizes); and
  - iv. have not been discovered to have breached Terms & Conditions of previous contests run by the Promoter (“**Eligible Entrants**”).
