

# Prilock Security Phish Trial Sweepstakes

## Official Rules

Entries received during the Sweepstakes Entry Period will be entered into a drawing for a chance to win the Prize described below. This Sweepstakes is only open to those who sign up at <https://www.prilock.com/special> or <https://www.prilock.com/phishtrial> or other authorized Prilock Security website.

### 2. BINDING AGREEMENT:

In order to enter the Sweepstakes, you must agree to these Official Rules. Therefore, please read these Official Rules prior to entry to ensure you understand and agree. You may not submit an entry to the Sweepstakes and are not eligible to receive the prize described in these Official Rules unless you agree to these Official Rules. These Official Rules form a binding legal agreement between you and the Prilock with respect to the Sweepstakes.

### 3. ELIGIBILITY:

The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia (excluding Puerto Rico and U.S. territories), who, as of the date of entry, (a) are 18 years of age or older, and (b) have internet access and an active company email account. By providing your email address, you grant Prilock the right to send you security newsletters and/or limited marketing messages. You may opt out of

receiving further Prilock promotional and/or marketing messages at any time by following the unsubscribe instructions in any email marketing message. Entries using macro, robotic, script or other forms of automatic entry will be disqualified. Entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to the email address by the company administrator or internet service provider that is responsible for assigning email addresses for the domain associated with the submitted email address.
