

Contest Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up at <https://www.kinbox.com/contest/> and who are 18 as of the date of entry. The Campaign is only open to legal residents of United States, Canada and United Kingdom, and is void where prohibited by law.
