

Cooking Craze Holiday Sweepstakes Official Rules
Big Fish Games, Inc. (“Big Fish”)

Eligibility. Void where prohibited by law. The Cooking Craze Holiday Sweepstakes (the “Sweepstakes”) is open to legal residents of one of the fifty (50) United States, the District of Columbia and Canada (excluding Quebec), who are 18 years or older (each, an “Entrant”).
