

# DuPage Forest Preserves Discovery Challenge Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up at the <https://dupageforest.wishpondpages.com/discovery-challenge/> and who are 18 as of the date of entry. The Campaign is only open to legal residents of Illinois and is void where prohibited by law. Employees of Forest Preserve District of DuPage County, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Forest Preserve District of DuPage County as final and binding as it relates to the content of this Campaign.

3. Campaign Period: Entries will be accepted online starting June 1, 2019, and ending on September 30, 2019.

4. How to Enter: The Campaign must be entered by submitting an entry using the online form provided at <https://dupageforest.wishpondpages.com/discovery-challenge/>. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Each entry must include one photo taken in a DuPage forest preserve during the contest period, between June 1 and Sept. 30. Entries that are incomplete or do not adhere to the Campaign rules or specifications and the Forest Preserve District of DuPage County’s General Use Ordinance may be disqualified at the sole discretion of Forest Preserve District of DuPage County. You may enter only one photo per challenge activity per forest preserve. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Forest Preserve District of DuPage County.

5. Prizes and Winner Selection: The Forest Preserve District of DuPage County will randomly select email addresses from all eligible entries on the following dates for the prizes below.

You can only win one monthly random drawing. However, if You do win a monthly random drawing, You would still be eligible to win one of the grand prize random drawings.

You can only win one grand prize random drawing.

## Monthly Random Drawings

July 1: Four-hour rental of a rowboat with trolling motor or a two-person kayak at Blackwell (approx. retail value \$80)

Oct. 4: Kayak with a paddle and personal flotation device, and guided kayak tour for six (Tour includes use of Forest Preserve District of DuPage County kayaks, paddles, and personal floatation devices.) (approx. retail value \$730)

The actual/appraised value may differ at the time of prize award. The specifics of the prize shall be solely determined by Forest Preserve District of DuPage County. No cash or other prize substitution shall be permitted except at the Forest Preserve District of DuPage County's discretion. The prize is nontransferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes or permits, shall be the sole responsibility of the Winner of the random drawing (the "Winner.") No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for the Forest Preserve District of DuPage County to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Notification: Winner will be notified by email within five (5) days following each random drawing. Forest Preserve District of DuPage County shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 5 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER (AT FOREST PRESERVE DISTRICT OF DUPAGE COUNTY'S SOLE DISCRETION) WILL RESULT IN WINNER'S DISQUALIFICATION AS WINNER OF THE CAMPAIGN, AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

Rights Granted by You: By entering this contest (e.g., photo, video, text, etc.), You understand and agree that the Forest Preserve District of DuPage County, anyone acting on behalf of the Forest Preserve District of DuPage County, and the Forest Preserve District of DuPage County's licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the World, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the Campaign, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes without any further compensation, notice, review, or consent. By entering this contest, You represent and warrant that your entry is an original work of authorship and does not violate any third party's proprietary or intellectual property rights. If your entry infringes upon the intellectual property right of another, You will be disqualified at the sole discretion of Forest Preserve District of DuPage County. If the content of your entry is claimed to constitute an infringement of any proprietary or intellectual proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. You also warrant that you received permission from any and all people in the photo, including the parents or legal guardians of people under 18 years of age. You shall indemnify, defend, and hold harmless Forest Preserve District of DuPage County from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which Forest Preserve District of DuPage County may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.

9. Terms & Conditions: Forest Preserve District of DuPage County reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond Forest Preserve District of DuPage County's control

corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, Forest Preserve District of DuPage County may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Forest Preserve District of DuPage County. Forest Preserve District of DuPage County reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. Forest Preserve District of DuPage County has the right, in its sole discretion, to maintain the integrity of the Campaign, to void entries for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Campaign may be a violation of criminal and civil laws. Should such an attempt be made, Forest Preserve District of DuPage County reserves the right to seek damages to the fullest extent permitted by law.

Limitation of Liability: By entering, You agree to release and hold harmless Forest Preserve District of DuPage County and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the Campaign and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error in the administration of the Promotion or the processing of entries.

11. Disputes: THIS CAMPAIGN IS GOVERNED BY THE LAWS OF USA AND ILLINOIS, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Campaign, participant agrees that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this Campaign, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Illinois having jurisdiction. Further, in any such dispute, under no circumstances shall participant be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Campaign). Participant further waives all rights to have damages multiplied or increased.

12. Privacy Policy: Information submitted with an entry is subject to the Privacy Policy stated on the Forest Preserve District of DuPage County website.

13. Sponsor: The Sponsor of the Campaign is Forest Preserve District of DuPage County.

14. Facebook: The Campaign hosted by Forest Preserve District of DuPage County is in no way sponsored, endorsed, administered by, or associated with Facebook.

15. By participating in the contest, You, the Contestant, have affirmatively reviewed, accepted, and agreed to all of the Official Rules & Regulations.
