

Contest Rules

By entering the Giveaway you agree to receive email communication and newsletters periodically from Walcraft Cabinetry. You can opt-out of receiving this communication at any time by clicking the unsubscribe link in the email. No purchase is necessary to enter or win. A purchase does not increase the chances of winning.

1. Eligibility: This Campaign is open only to those who sign up at the <https://walcraftcabinetry.wishpondpages.com/fabuwood-cabinets/> and who are 21 as of the date of entry. The Campaign is only open to legal residents of the United States, and is void where prohibited by law. Employees of Walcraft Cabinetry, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

3. Campaign Period: Entries will be accepted online starting January 1, 2020 and ending on February 28, 2020 at 3 PM PT. All online entries must be received by February 28, 2020 at 3 PM PT.

4. How to Enter: The Campaign must be entered by submitting an entry using the online form provided at <https://walcraftcabinetry.wishpondpages.com/fabuwood-cabinets/>. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Walcraft Cabinetry. Optional verbiage to include: You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use
