Java House® National Cold Brew Day Sweepstakes (04/11/2021 - 04/20/2021)

NO PURCHASE NECESSARY TO ENTER OR WIN.

1. PROMOTION DESCRIPTION: The Java House National Cold Brew Day Sweepstakes (“Sweepstakes”) begins on 04/11/21, at 12:00:00 AM Eastern Time (“ET”) and ends on 04/20/21, at 11:59:59 PM ET (“Promotion Period”). There will be Ten (10) potential winners of the Sweepstakes, to be determined by random drawing from among all eligible entries received during the Promotion Period.

2. ELIGIBILITY: Open to legal residents of the United States who are eighteen (18) years of age or older (except in the case of legal residents of certain states where the legal age of majority is greater than eighteen (18) years of age, such legal age of majority) at the time of entry. Employees of Heartland FPG and their immediate family members and/or those living in the same household of each, and any individual who has been awarded a prize in any promotion sponsored by Heartland FPG in the past 12 months are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited.

3. HOW TO ENTER: To enter the Sweepstakes:

Entrants fill out all required fields in the official entry form. Once an entrant has entered, they will then be given the option to earn additional entries into the contest by completing tasks listed on the sweepstakes page by using the links provided.

Limit one (1) entry per person/email address during the sweepstakes period. In the event of a dispute regarding entries based on the identity of the entrant, entries will be deemed to have been submitted by the Authorized Account Holder of the email address provided at the time of entry. “Authorized Account Holder” means the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization that is responsible for assigning e- mail addresses for the domain associated with the submitted e-mail address. Entrants may not participate with multiple e-mail addresses, nor may entrants use any device or artifice to enter more than once per day. WINNER NOTIFICATION: Potential winners will be notified via the e-mail address submitted with their entry and must respond to such notification within forty-eight (48) hours of delivery to be eligible to receive a prize.
