

Contest Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up at the <https://homicreations.wishpondpages.com/shopping-spree/> and who are 18 as of the date of entry. The Campaign is only open to legal residents of United States, Canada, and is void where prohibited by law. Employees of Homi Creations, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Homi Creations. Optional verbiage to include: You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. In such case, Homi Creations may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Homi Creations. Homi Creations reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the

entry process or the operation of the Campaign or website or violates these Terms & Conditions. Homi Creations has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
