

# Contest Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up at the <https://philiciaalice.wishpondpages.com/giveaway/> and who are 18 as of the date of entry. The Campaign is only open to legal residents of Canada/US, and is void where prohibited by law. Employees of Philicia Alice, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign.
