

Contest Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up at the <https://neverendingcookiejar.wishpondpages.com/giveaway> and who are 21 as of the date of entry. The Campaign is only open to legal residents of United States, and is void where prohibited by law. Employees of The Never Ending Cookie Jar, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign.
