

Contest Rules:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up at the <https://campaign.divineteashop.com/giveaway/> and who are 18 as of the date of entry. The Campaign is only open to legal residents of United States, and is void where prohibited by law.
